Item 9. – Other Events

Banco de Oro Unibank, Inc. (BDO) has notified Atlas Consolidated Mining and Development Corporation (Atlas) that it will further exercise its rights under the warrants issued in its name pursuant to the 27 November 2009 Convertible Loan and Security Agreement among Atlas, BDO and Globalfund Holdings, Inc (the “Warrants”). As stated in the subscription notice received by Atlas on 22 September 2010, the exercise will cover 6,000,000 Atlas common shares to be subscribed at the price of PhP10.00 per share.

To date, BDO has already exercised its subscription rights with respect to 9,000,000 out of a total of 18,728,000 Atlas common shares underlying the Warrants.
