Atlas Consolidated Mining and Development Corporation (Atlas) is pleased to report the successful completion on 19 April 2010 of its sixth shipment of copper concentrates for this year through its subsidiary Carmen Copper Corporation (CCC).

The shipped concentrates which were produced from the Toledo copper mine in Toledo City, Cebu had a total volume of 5,231.805 wet metric tons (wmt) and contained 29.11% copper, 3.04 grams gold/dry metric ton (dmt), and 24.58 grams silver/dmt based on preliminary assays. They are consigned to the smelter Jiangxi Copper Company Ltd. of Jiangxi Province, P.R.O. China.

The latest shipment which has an estimated value of US\$9,850,000.00 constitutes the 19th made by CCC since the start of its commercial operations. To date, CCC has already exported 93,773.433 dry metric tons of copper concentrates to China.
