The shipped concentrates which were produced from the Carmen copper mine in Toledo City, Cebu had a total volume of 5,234.865 wet metric tons (wmt) and contained 28.19% copper, 2.83 grams gold/dry metric ton

(dmt), and 24.88 grams silver/dmt based on preliminary assays. They are

consigned to the smelter Jinlong Copper Company Ltd. of Tongling

The latest shipment which has an estimated value of US\$9,176,000.00 constitutes the 20th made by CCC since the start of its commercial operations. To date, CCC has already exported 98,520.21 dry metric tons

The Carmen copper mine has already processed over 2.5 million tonnes of copper for this guarter and production rates are expected to exceed
