Atlas Consolidated Mining and Development Corporation (Atlas) reports the successful completion on 28 June 2010 of the ninth (9<sup>th</sup>) shipment of copper concentrates for this year of its subsidiary Carmen Copper Corporation (CCC).

The concentrates were loaded on board M/V "VSG Pride" that is destined for Onsan, South Korea. This is CCC's first shipment of copper concentrates to a consignor outside of China to where 103,462 dry metric tons (dmt) of copper concentrates have already been shipped over 21 consignments with an aggregate sales value of US\$164 million.

The shipped concentrates which were produced from the Carmen copper mine in Toledo City, Cebu had a total volume of 5,241.647 wet metric tons (wmt) and contained 28.35% copper, 2.97 grams gold/dry metric ton (dmt), and 23.29 grams silver/dmt based on preliminary assays. The shipment which has an estimated value of USD 10.113 million is consigned to LS-Nikko Copper Inc. in Korea.

The next shipment is expected to be completed during the first week of July. As of the date of this report, 5,000 wmt of copper concentrates are already stockpiled in CCC's concentrate bins at its Sangi port in Cebu for the early July shipment. Another shipment is scheduled on 22 July 2010.
